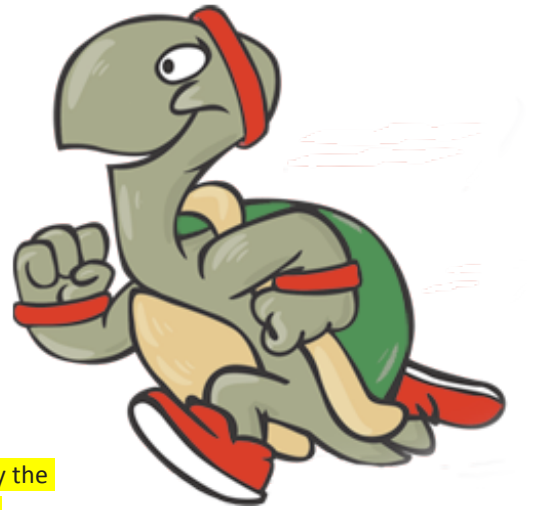

I recognize that if I choose to wear a portable listening device during the race that it may create a distraction, which may increase my risk of injury. Knowing these facts, and in consideration of your acceptance of my entry fee, I hereby for myself, my heirs, executors, administrators or anyone else who might claim on my behalf, covenant not to sue, and waive, release, and discharge Perham Cross Country Boosters and any organization associated with the race, and the local governments and police, volunteers, and any and all sponsors including their agents, employees, assigns or anyone acting on their behalf, from any and all claims or causes of action (known or unknown, foreseen or unforeseen) for death, personal injury or property damage of any kind or nature arising out of their negligence or that of others in the course of, my participation in this road race and all other events and activities associated with this race. I give my permission for medical team evaluation, treatment, and transfer to an emergency facility if needed. I agree that Perham Cross Country Boosters officials have the right to remove me from the race and related activities if they are of the opinion that it is in my best interest or the best interest of Perham Cross Country Boosters that I be removed. I further grant permission to the Perham Cross Country Boosters and/or agents authorized by them to use any photographs, videotapes, motion pictures, recordings, and any other record of this event for any purpose without limitation or compensation. I understand that fees are not refundable and race numbers and timing chips (if applicable) are not transferable. I also agree to abide by the Rules of Competition as set forth by the USATF. I have read the foregoing and certify my agreement by signing the Registration Form.

THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, and agreement is intended to be as broad and inclusive as permitted by the law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
